NOTICE INVITING TENDER

CHAIRMAN (SMB) invites Sealed tender in prescribed form on behalf of Silchar Municipal Board for the work tabled below with a validity period of 180 days, from eligible registered contractor of APWD Building or Roads of appropriate class with sound financial back ground and having experience of executing similar Value of work in single Tender in last three years which will be received by the undersigned at his office up to 2.00 P.M on or before 15.03.2019.and will be opened on the same date at 4.00P.M.in presence of the intending tenderers. Earnest money at the rate of 2% of the value of work (1% for S.C, ST, OBC and unemployed graduate Engineer) in the form of call deposit/Bank Draft /F.D of Nationalized Bank duly pledged in favour of the chairman, silchar Municipal Board silchar will have to be deposited along with tender paper. The Tender should be submitted in two bid system i.e. **Envelop-1** shall contain the technical bid and **Envelop-2** should contain financial bid or price bid. The name of work should be super scribed in bold letters on the envelop and the respective bid document contained in it, both the envelops should be sealed in a single big size envelope containing name of work, detail name, address and contact number of contractor. First the envelop-1 shall be opened and if the tenderer qualifies in technical bid envelop-2 i.e. the price bid will be opened. If the day of opening tender happens to be bondh or office closed due to any unforeseen reason the tender will be received and opened on the next working day. During agreement the tender will be eventually drawn on F-2 form and all APWD terms and conditions will be applicable.

The details tender papers may be obtained from the office of the, silchar Municipal Board , silchar by intending tenders on payment against coat of tender documents in cash which is not refundable, during office hours on all working days from the date of NIT being hung up .


