Prevention, Preparedness & Mitigation Activities:

- 1. Departmental DM Plan:** District Disaster Management Authority, Cachar has taken up the initiative for preparation of District Level Departmental DM Plan of selected 16 (sixteen) nos. of Departments under aegis of the Assam State Disaster Management Authority (ASDMA), Govt. of Assam. State level training was also organized for the same in Guwahati for preparation of Departmental DM Plan.

Accordingly 15 (Fifteen) nos. of Departments have prepared and submitted the Departmental DM Plan to DDMA (both soft & hard copies) and it has also been shared with ASDMA.

DDMA, Cachar has also organized a presentation of the Departmental DM Plan on 16th September 2015 and in this meeting 8 (eight) nos. of Departments have given their Departmental DM Plan for appraisal of the Deputy Commissioner cum Chairman, DDMA.

It has also decided in the meeting that from November 2015 onwards, all the DDMA's meeting, one or two Departments must present (PPT) their respective Departmental DM Plan for appraisal of the DDMA.

Out of total 16 (sixteen) Departments, only Water Resource Department did not submit the Plan instead of repeated reminder from DDMA.

- 2. Village Master Plan:** DDMA, Cachar selected Chibitabichia Part – IV revenue village under Tapang Development Block and Silchar Sadar Circle for preparation of model Village Master Plan of the District. Accordingly, all the Departments shared information about the concerned village and also visited the village for meeting with community. DDMA has also conducted a community meeting with all the Departments representatives at the village to discuss about the Village Master Plan and other concerned issues related this village. 6 (six) rounds of meeting was held with

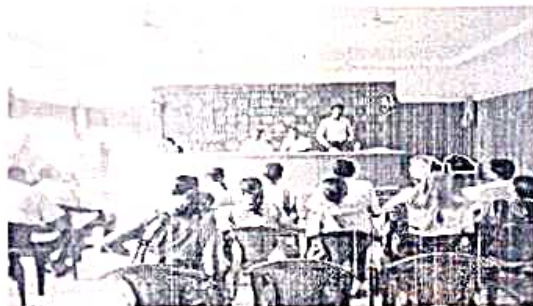


Departments and community for the whole preparation process and finally the meeting held with VLMCC of the same village for approval of the draft Village Master Plan on 10th December 2015.

The final Village Master Plan has already shared with ASDMA both soft and hard copies.

The Village Master Plan sharing workshop was held on 1st week of February 2016 at DRDA Conference Hall for dissemination of the plan among the various Departments and VLMCCs and also with PRI representatives. All the concerned Department will present their Departmental role for preparation of Village Master Plan and also roadmap for rest 866 nos. of Village Master Plan for revenue villages and in consultation with VLMCCs. DPO, DDMA has also presented Village Master Plan and strategy for preparation taken by the DDMA.

3. **VLMCC Formation:** As per Govt. OM, the DDMA has instructed all the Circle Officers to constitute a VLMCC in each revenue village of the Circle and notified it accordingly.
In Cachar, all Circles have completed the formation process in all revenue villages except 6 nos. of revenue villages which are without human habitation. Total 867 nos. of revenue villages in Cachar and 861 nos. VLMCCs formed and the copy of the notification is also available with DDMA.
4. **VLMCC Members Training:** VLMCC Members training has completed on Sonai and Udharbhond Revenue Circles and Silchar Sadar, Katigorah and Lakhipur is yet to complete the same. The training is under process in these Circles.

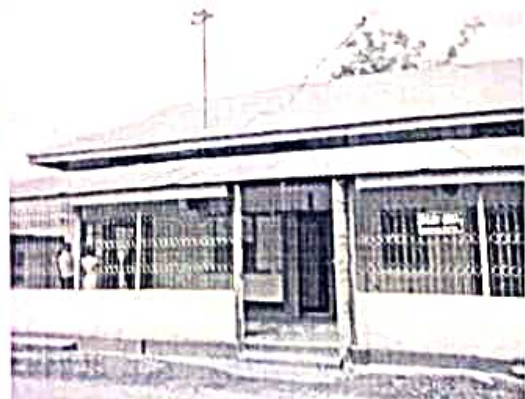

For flood relief operation in 2015, the following G.R. materials were issued to the camps inmates under Katigorah Revenue Circle.

During the flood in September, 2015, a total of 349 (three hundred forty nine) nos. kutchha houses under Katigorah Revenue Circle were partly damaged. An amount of Rs. 11, 16,800/- (Rupees eleven lakh sixteen thousand eight hundred) only was sanctioned as Rehabilitation Grant to the affected families @ Rs. 3,200/- each vide this office letter no. CRR.33/2015/75 dated 05.12.2015. 1 (one) pucca houses was completely damaged and R.G. for Rs. 95,100/- was sanctioned vide this office letter No. CRR.33/2015/69 dated 18.09.2015.

Death Cases due to natural disasters in 2015:

1) 2 (Two) children died during the 2015 flood under Katigora and Sonai Revenue Circles viz. Hasan Ahmed Laskar, S/O Jakir Hussain Laskar, Age – 8 years of Village Dakshin Mohanpur Part - X&Debojit Das, S/O Kirendra Das, Age – 5 years 6 months of Village Chandinagar Part – IV. DDMA has moved to Govt. for sanctioning ex-gratis of Rs. 4.0 lacs to NOK of deceased children's.

2) 5 (five) persons namely (1). Zabeda Khatun w/o. Jamal Uddin of Tarapur T.E., Lakhipur, (2). Zesmin Begum D/o. Jamal Uddin of Tarapur T.E., Lakhipur, (3). Papaiya Begum D/o. Jamal Uddin of Tarapur T.E., Lakhipur (4) Atomba Ali S/o. Jamal Uddin of Tarapur T.E., Lakhipur and (5) Zakir Ali S/o., Jamal Uddin of Tarapur T.E., at Lakhipur died due to landslide that occurred on 21.07.2015. Ex-Gratia Grant of Rs. 4, 00,000/- (Rupees four lakh) each was sanctioned to the NOK of the deceased person vide sanction letter No. CRR.75/2012/62 dated 18.09.2015.

3) 1 (one) Sabul Hussain Laskar S/o. Dilaharilal Laskar of village Ambicapur Part-VI (Atalbasti), Dist. Cachar died due to cyclonic storm on 04.04.2015. Ex-gratia grant of Rs.4, 00,000/-

(Rupees four lakh) only was sanctioned to NOK of the deceased person vide this office Sanction letter No. CRR.3/2014/183 dated 30.09.2015.

4) 3 (three) persons namely (1). RejaulHaqueBarbhuiya of village Gossaipur Part-III, Udharbond, (2). Mohidul Islam Barbhuiya of village Gossaipur Part-III, Udharbond and (3). Tahir HussainBarbhuiya of village Gossaipur Part-III, Udharbond died due to lightning that occurred on 09.06.2015. Exgratia Grant of Rs. 4, 00,000/- (Rupees four Lakh) only was sanctioned each to the NOK of the deceased persons vide this office letter NO. CRR. 12/2015/111 dated 09.12.2015.

Total 11 (eleven) nos. of persons died in 2015 due to natural disaster.

Best Practices (Case Study)

Land Slide at UjanTarapur:

Ujan Tarapur village situated under Lakhipur Constituency and Lakhipur Revenue Circle, falls in Latitude 24°-15' North and Longitude 92°-35' East was suffered from a devastating landslide particularly in the house of Jamal Uddin, a day labour due to heavy and continuous rain fall on the 21st July, Tuesday at 8:30 P.M .

Jamal Uddin was not at home by the time the disaster occurred. As he was a day labour he used to go out from his home in the morning in his work place at Poilapool and returned home in the evening. But on that day due to heavy rainfall he could not come out from work place. However this hindrance could not prevent him from returning home in the rain. He reached home at 10:00 P.M. and saw that his house was under a mass of soil. The neighbours were quite ignorant of the disaster. Jamal though knew that there was a hazard near his house and it was in a vulnerable position, did not give a second thought on it. When he saw the condition of the house he began to shout for help. The neighbours heard his hue and cry and came out for his help .with the help of the neighbours his two minor sons Jekib Ali (5 years) and Asab Ali (9 years) were rescued and they were immediately sent to Private Nursing Home at Poilapool.

In the meantime the message of the unwanted hazard was received by the District Emergency Operation Centre (Control Room) at 10 P.M. It was also reported that five persons were missing in the land slide.

No sooner had the information received by the District Emergency Operation Centre (Control Room) than it was informed to the Deputy Commissioner, Cachar, Silchar and as per his instruction immediately it was informed to SDRF & Fire service, Silchar, Health Department, Lakhipur and Banskandi Police Station, Police Control Room, Ambulance Service Provider and getting information from local GoanPanchayat President on hourly basis.

Very soon a rescue team under State Disaster Response Force reached at the spot at 11:00 P.M. with all equipment's and were ready to start their rescue operation.

Just after the departure of the rescue team, the officials of DDMA headed by Sri Baranya Das, ADC cum CEO DDMA, Sri Shamim Ahmed Laskar, DPO, DDMA, Sri P. K. Gupta, Circle Officer, Lakhipur Revenue Circle and Dr.SudipJoyti Das, Joint Director of Health Services, Cachar rushed to the spot at 11:30 P.M. with Ambulances from Silchar. As soon as the officials reached the incident spot they immediately started monitoring to rescue operation .The officials, without feeling pain stood there whole the rainy night.

The officials arranged 3 nos. of JCBs for rescue operation from Banskandi and Poilapool and all the 3 nos. of JCBs worked throughout the night along with SDRF and other rescue team and the volunteers from the different communities in and around UjanTarapur. It will not be out of place to mention here that the role so performed by Sri Nazrul Islam, G.P.President of UjanTarapurGaonPanchayat was praiseworthy. He is an ex-serviceman. He is also trained in Search and Rescue by DDMA, Cachar, Silchar in 2012-13. It reflects that during the rescue operation he took the leading role and from the front side he led the volunteers gathered from UjanTarapur and from the periphery of that area who assembled for rescue operation from the different communities. He also communicated with DDMA officials time to time. His approach indeed was a praiseworthy one.

The rescue parties worked ceaselessly throughout the night. The parties did not show any fatigue. It was due to their utmost services & efforts they could find out the five numbers of dead bodies from the debris on the 22nd July 2015 in the morning at 8 A.M. The five deceased persons were JabedaKhatun (30), Jakir Ali (12), Atomba Ali (7), Papiya Begum (8) and Jasmina Begum (14). The injured persons were Jacob Ali (5) and Asab Ali (9). Only Jamal Uddin (35) remained safe as he was away from home.

It was reported by the local people that Jamal Uddin's family consists of eight members and their ages are from 5(Five) years to 12 (Twelve) years. He had four sons and two daughters. He lives Below Poverty Line (BPL).

Besides, it was also reported that although this sad demise happened due to natural disaster, it was mostly blamed to the neighbour Nikhil Dev and Reba Dev. The neighbours claimed that A.P member of Manikpur-JarapurGaonPanchayatSmti. Reba Devi's house was on the top of the hill and at the foot hill lies the hovel of Jamal Uddin. To enhance the beauty of the house of the A.P member Reba Dev, the high hill was cut and tried to make it plain. Jamal Uddin requested Nikhil Dev to stop cutting the hill for there was a chance of occurring a landslide. But Nikhil Dev and Reba Dev did not pay any

heed to the pray of Jamal Uddin. Today the Dev Couple's house stood in danger free position.

Jamal Uddin and his two sons left the place and took refuge in a safe place. The administrative officers and MLA of Lakhipur constituency Sri Rajdeep Goala advised the people of the neighbouring areas to leave their living place and go to some other safe place.

The deceased, after rescuing from the debris were sent for post mortem by an ambulance at Silchar Medical Collage & Hospital. The DEOC (Control Room) already informed the Medical College authority for immediate necessary action for post-mortem of all the five persons and sent all the dead bodies to the native village for cremation after NAMAZ -E- ZANAZA on the evening of 22nd July 2015.

It is worthy to mention here that DDMA, Cachar, undertook the full responsibility in monitoring all the action at a close angle from the beginning to the end. It was due to their active supervision the difficult job could be done very easily and quickly.

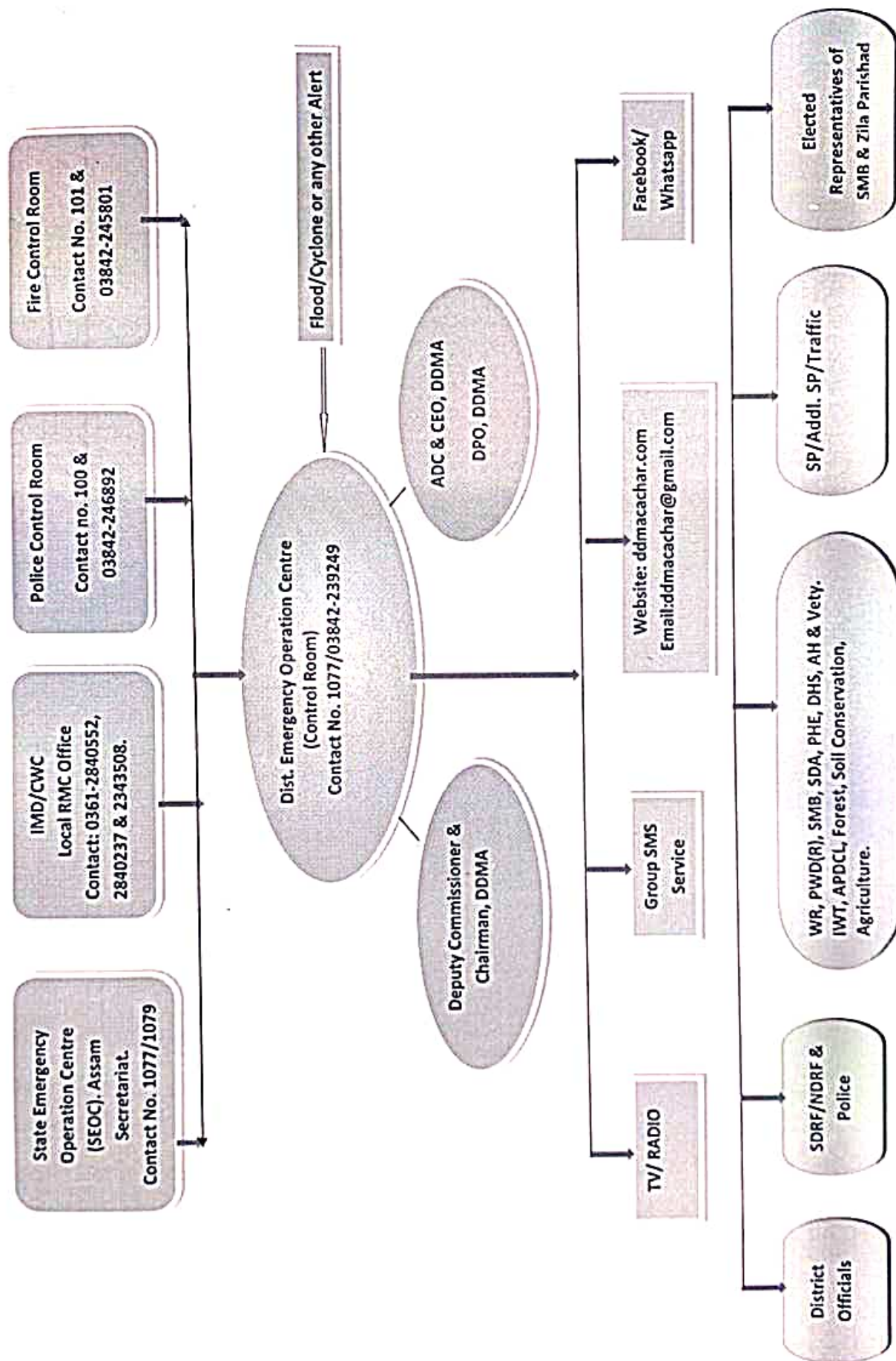
Sri Rajdeep Goala, the local MLA of Lakhipur constituency also initiated the rescue work from Tuesday night to till Wednesday and also appreciate efforts taken by the District Authority.

The dead bodies, after reaching the village Ujan Tarapur was taken to Moragang Village of Tarapur and performed NAMAZ-A-JANAZA by thousands of sorrowful people and then cremation was performed at 6 P.M. People from different casts and religious groups were present there.

On the other hand, the most important task performed by Sri S. Viswanathan, the Deputy Commissioner, cum Chairman, DDMA, Cachar, on Wednesday informed Assam State Disaster Management Authority stating all the description vividly through a message. After the occurrence of the Disaster, a team of SDRF was sent to the incidental spot and he clearly explained the matter. He directed the Lakhipur S.D.O (Civil) to submit the Post-Mortem Report & Medical Certificate stating the reasons of the death.

Thus the District Administration and the District Disaster Management Authority, Cachar leave no plan untried to help the family of the victim of Landslide. It was due to their sincere effort, active participation, quick and prompt action could easily find out the dead bodies from debris. The sincere effort of the District Disaster Management Authority could not but praise.

Emergency management exercise begins today
