- 1. The house reviewed the district preparedness and direct to strict vigil of the situation.
- 2. DDMA meeting need to be conducted regularly for monitoring for overall preparedness and response plan of the District for Corona Virus.
- 3. Red-Cross Society and Lions Club Silchar to be involved for awareness purpose.
- 4. Jt. Director of Health Services to ensure fixing of Hoardings, Banners in each Tea-Estate of Cachar District.
- 5. DIPR BV Region to ensure Miking/Announcement on Do's and Don'ts in Connection to COVID19 throughout the District Two to Three times a Day.
- 6. All Beauty Parlor/Salon to be shut down immediately as precautionary measure taken by the District Administration, Cachar in Connection to COVID19 until further order issued.
- 7. Precautionary measures to be taken by all the Malls of Cachar District such as Display of Do's and Don'ts in front of Entry and Exit, Hand Wash facility to be installed at the entry point of the Concerned Malls.
- 8. All CO's, OC's to ensure Prohibitory order on illegal Wet Market, Selling of Meat, Fish Chopped Fruits, Vegetables and Semi-Cooked food in open areas.
- 9. Brick-Kiln Industry to be stopped immediately.
- 10. All CO's to ensure installation of Hoardings, Banners on Do's and Don'ts in Connection to COVID-19 in Collaboration with Jt. Director of Health Services.
- 11. All Heads of Department to ensure Cleanliness/Sanitization of Office Premises on Hourly basis.
- 12. Jt. Director of Health Services, Cachar to ensure safety of Doctors and Staff involved in screening operation at all screening locations.
- 13. Superintendent of Police to ensure Closure of all Bars in the District immediately.
- 14. Airport Authority of India, Kumbhirgram Silchar to ensure Disinfection of the Airport Premises Luggage's, Luggage Bay, Aircraft on arrival of every New Flight.
- 15. Hotel Association to provide 100 Nos. of Rooms in order to create Quarantine Zones.
- 16. Jt. Director of Health Services to ensure Miking, Distribution of IEC Materials in Connection to COVID19 in the entire District especially in the rural areas.
- 17. All officials of the District Govt. /PSU's etc. are directed to keep their Mobile Phone on for any emergency necessary assistance.
