

MINUTES OF DISTRICT DISASTER MANAGEMENT AUTHORITY (DDMA) MEETING
HELD ON 9TH JULY, 2022 AT 3.00 P.M IN THE CONFERENCE HALL OF OFFICE OF
THE DEPUTY COMMISSIONER, CACHAR

Members present as per Annexure-A:

The meeting was presided over by Smti. Keerthi Jalli, I.A.S., Deputy Commissioner cum Chairperson, District Disaster Management Authority, Cachar, Silchar.

At the outset the Deputy Commissioner, Cachar welcomed all the members and thereafter discussion was initiated as per agenda.

After threadbare discussion, the following decisions have been taken on the Agenda items.

- 1) First of all, Confirmation of the minutes of the last DDMA Meeting held on 19th April, 2022 was done and discussion was undertaken on the action taken on the decision of the last meeting.
- 2) Schemes that require immediate restoration & for which the work can be started immediately should be submitted by concerned Departments after getting it duly signed by concerned Circle Officer.
(Action: All Line Departments)
- 3) For assessment & preparation of estimates with regard to damages of Anganwadi Centres of Cachar District, PWD(Building Division), Cachar will have to engage their engineers.
(Action: PWD, Building Division, Cachar)
- 4) For damage with regard to Schools, decision needs to be taken by concerned Head of Department that whether the work needs to be taken up now or can be undertaken after completion of monsoon, so as to evade repetition if flood takes place again.
(Action: IS, CDC, Cachar/DEEO, Cachar)
- 5) A detail report regarding the status of functioning of all Sluice Gates of Cachar needs to be submitted to DDMA, Cachar within next 3(three) days i.e within 18th July, 2022.
(Action: Water Resource, Mechanical Division, Cachar)
- 6) Provisions for construction of culverts in areas where roads gets affected due to river/canal water flowing across may be submitted by concerned Department to DDMA, Cachar.
(Action: PWD, Territorial Road(all four) Division, Cachar)
- 7) Vulnerable dykes like the one at Tarapur Shibbari Road/Sloughening at Tundurkandi, etc needs to be considered for immediate restoration & estimates to be submitted accordingly
(Action: Water Resource, Civil Division, Silchar/C.I Division, Badarpur)
- 8) Roads which were inundated due to Floods in Silchar Town like Chandicharan Road, Bilpar Road, Public School Road, Ashram Road, Sonai Road, road near Holy Cross School, Shyamananda Ashram Road, Road towards ISBT & Nearby FCI Godown through Chirukandi may be considered as priority roads & needs to be considered for immediate restoration & estimates to be submitted accordingly.

For various roads under all the 26 number of wards which were flooded needs to be considered for immediate restoration & estimates to be submitted accordingly.

Further, the road at the Chowrangee Area/area near Mahadevpur Bus Stand/Peernagar Khushiarpur under Katigorah Revenue Circle needs to be considered for similar restoration as proposed by concerned Circle Officer.

(Action: PWD, Territorial Road(all four) Division, PWD (NH) Division, Cachar)

- 9) PHE Asset located near DFO Office/Post Office, Sadarghat needs to be considering immediately for sealing/curing as this area might lead to any accident in the near future.

(Action: PHE, Division-I, Cachar)

- 10) DTR Restoration & lifting to a safe height needs to be expedited.

(Action: APDCL, Cachar)

- 11) Roads in various villages which have been affected by flood & falls under jurisdiction of CEO, Zilla Parishad, Cachar may be considered under schemes under their department like MNREGA, etc

(Action: CEO, Zilla Parishad, Cachar)

- 12) Various damages with regard to line departments which require immediate restoration needs to be submitted to DDMA, Cachar for inclusion in FRIMS report. Departmental damages may be verified by concerned Circle Officers by engaging their LR staff & the same may be approved in CLTF Meetings.

(Action: All Circle Officers, Cachar/All Line Departments, Cachar)

- 13) Mega Vaccination Camps to be organized for animals by A.H & Vety Department & for this doctors are to be managed from School of Vety Science, Cachar/ICDP/others. Further, District Veterinary Officer, Cachar is directed to write to the Director, Veterinary Department for providing FMD Vaccines/etc.

(Action: District Veterinary Officer ,A.H & Vety , Cachar)

- 14) Restoration of various schemes of PHE Division which are affected by flood needs to be completed within 7(Seven) Days. Bleaching Powder & Halogen Tablets needs to be handed over to Circle Officers in proportionate amount in addition to their current stock considering current Flood Situation.

(Action: PHE, Division-I/II, Cachar)

- 15) Tara Pumps to be installed in all Relief Camps & order for placing the same to be issued by today itself. The installation needs to be completed within 14th July, 2022. Also, the non-functional pump at Rajatilla H.S School needs to be immediately repaired & re-installed.

(Action: PHE, Division-I/II, Cachar)

- 16) Daily report on restoration of damaged schemes needs to be submitted by Irrigation Department to DDMA, Cachar.

(Action: Irrigation,(all four) Division, Cachar)

- 17) Agriculture Department is directed to submit proposal with regard to de-siltation of crop lands to DDMA, Cachar after formulating a proper planning with Engineering Section of Agriculture Department & ADOs are directed to co-ordinate accordingly.

(Action: Agriculture Department, Cachar)
