

MINUTES OF THE MEETING WITH BUSINESS / MARKET ASSOCIATIONS TO DISCUSS THE ISSUES REGARDING OPENING OF SHOPS FOLLOWING THE 3RD LOCKDOWN IMPOSED FROM 04/05/2020 DUE TO OUTBREAK OF COVID -19; HELD ON 04/05/2020 AT 11:30 AM IN THE CONFERENCE HALL OF THE OFFICE OF THE DEPUTY COMMISSIONER, CACHAR, SILCHAR.

Members present :- As per Annexure – A.

The meeting was chaired by Smti. Barnali Sharma, ACS, Deputy Commissioner, Cachar, Silchar. Initiating the discussion, she welcomed all the members present in the meeting and thanked everybody for the help and support extended from their respective end due to which the period upto 2nd phase of Lockdown passed off peacefully in Cachar District and the District has moved into Green Zone.

Thereafter, she briefed everybody regarding the measures to be taken in respect of opening of shops during the 3rd phase of Lockdown from 04/05/2020 to 17/05/2020. Then she readout the guidelines and instructions in this regard received from the Government of Assam and urged everybody to do the needful from their respective end to ensure that all the instructions are complied with in totality. She also informed that any violation of the said instructions would be treated as punishable offence under Disaster Management Act, 2005, as contained in the order issued by the Govt. of Assam.

After threadbare discussion on all the matters, following decisions were taken :-

- 1) Market Associations / Shopkeepers in particular localities are to prepare a roster for opening of shops, keeping in mind that two shops are kept closed in between two open shops in every locality on a particular day and in doing so it should be kept in mind that all the shops in the locality get their turn to keep open as per their turn. The said roster mentioning the (i) Shop Number (ii) Name of Shop etc. should be submitted to Addl. Deputy Commissioner (Magistracy), Cachar and Addl. Deputy Commissioner (DDMA), Cachar by 04:00 PM of 04/05/2020; with a copy to Deputy Commissioner, Cachar, Silchar.
- 2) For identification of shops and preparation of roster, Market Inspectors of respective Municipal Boards have been directed to extend necessary cooperation to the Market Associations / Shopkeepers.
- 3) Pharmacies / Shops of Essential Commodities may be kept open as per guideline, provided that instructions related to social distancing etc., which are already in force are strictly adhered to.
- 4) Owners of all the shops must ensure proper sanitization and wearing of masks by both sellers and customers.
- 5) Shopping Malls / Market complexes / Cinema Halls etc. shall remain totally closed.
- 6) Retail vegetable / fish markets , bazaars, haats etc to remain totally closed. Door-step delivery may be provided.
- 7) For Wholesale vegetable Market at New Market, Fatak Bazar; which is congested and witnesses crowding; it was suggested if any other suitable open place can be identified for unloading of vegetables etc in order to ensure that social distancing is properly maintained.

Towards the end of the meeting, the Deputy Commissioner once again urged all concerned to remain extremely careful and take all necessary precautions to prevent the spread of COVID -19 through contact or otherwise. At the same time, she also hoped that everybody would get the chance to carry on their business with strict compliance to the Government Instructions; for a secure survival in the coming days.

The meeting ended with vote of thanks from the chair.
