3. Division informed the House that 5 projects have been physically completed and 1 project, the work order of which was issued on 02-06-2021 will be started soon . The District Development Commissioner, Cachar requested the EE, Cachar Inv. W.R. Division to expedite as the flood season has ended.

6. INDUSTRY: The Assistant Manager, DICC informed that the second phase verification of Re-Sveyam has not been completed. Taking due cognizance of the plight of unemployed youths, the District Development Commissioner, Cachar instructed the Assistant Manager, DICC, Cachar to expedite the works relating to the Re-Sveyam disbursement process by coordinating with all concerned.
