- 8. Purchase of scrap(s) shall be awarded to the highest bidder of each type of scrap. Material to be lifted entirely within 3 working days of awarding the Purchase i.e. by 5PM of 1st January 2021 failing which this office is not responsible for any loss, theft, pilferage etc.
- 9. Successful bidder will be required to deposit 25% of his/her total bid values on the spot either in cash or cheque drawn in favour of "Silchar Municipal Board". The Balance Amount shall be deposited before lifting the material.

In case the highest bidder fails to deposit the full amount as per award of tender within prescribed time or fail to lift scrap within 3 days from the date of award of bid, his/her bid shall be cancelled, and the deposit amount forfeited. - 13. Use of unethical practices during the process shall lead to rejection of concerned bid.
- 14. The office of Executive Officer, Silchar Municipal Board reserved the right to accept or reject summarily any or all tenders as a whole or any part thereof, without assigning any reason whatsoever.
