

**MINUTES OF THE DDC MEETING HELD ON 26<sup>th</sup> May, 2023 AT 11.30 A.M. IN THE NEW CONFERENCE HALL OF THE DEPUTY COMMISSIONER, CACHAR, SILCHAR.**

The meeting was presided by Rajib Roy, ACS, District Development Commissioner, Cachar.

At the outset, he welcomed all the members present in the meeting. Then Department wise discussions were started, which were recorded as follows:

**i. AGRICULTURE**

The District Agriculture Officer, Cachar apprised the Dist. Development Commissioner, Cachar about projects undertaken by the Department. The DDC instructed the DAO, Cachar to increase Aadhaar authentication in PM-Kisan. On enquiring about the FPO's in the district, the DAO informed the District Development Commissioner, Cachar that 3 (three) more FPO's will be formed before June'23. The DAO also informed that Organic pineapple will be exported to Dubai in the month of June. The DDC instructed the DAO to distribute HMNEH toolkit before the month of June'23.

**ii. APDCL–**

The AGM, APDCL apprised the Dist. Development Commissioner, Cachar about the various projects undertaken by the Department. The Dist. Development Commissioner, Cachar instructed the AGM, APDCL to distribute LED lights/bulbs under MMADY to all the Government Offices/institutions in Cachar as soon as possible. The AGM, APDCL informed the DDC that schemes under AIIB will be completed in stipulated time.

**iii. FISHERY –**

The DFDO, Cachar informed the District Development Commissioner, Cachar that PMSSY schemes under F/Y 2021-22 would be completed by the month of May, 2023 while those under F/Y 2022-23 would be completed before the end of next Financial year, i.e. 31<sup>st</sup> March 2024. The DDC Cachar instructed to expedite.

**iv. HEALTH–**

The Jt. Director of Health Services, Cachar apprised the Dist. Development Commissioner, Cachar about the various projects undertaken by the Department. The Jt. Director of Health Services, Cachar informed that Govt. of India has decided to eliminate Tuberculosis by 2025. He also informed that there are 1383 active TB patients in the District. In this context the Dist. Development Commissioner requested all Heads of Department to adopt at least 2 TB patients and provide them with Rs.500 per month for a duration of 6 months so that the deadly disease of Tuberculosis can be eliminated from the District.

**v. EDUCATION**

The DMC, SSA, Cachar apprised the Dist. Development Commissioner, Cachar about the various projects undertaken by the Department. The DMC informed that all the schemes under RIDF will be completed before 30<sup>th</sup> June' 2023.

**vi. SPORTS**

The District Sports Officer, Silchar apprised the District Development Commissioner Cachar, Silchar about the numerous projects carried out by the Department. The District Sports Officer informed that out of 20 ongoing schemes, 6 has been completed, another 4 nos. of schemes will be completed before 31<sup>st</sup> May and the remaining 10 schemes would be completed in December, 2023. The DDC requested to expedite after reviewing the progress report submitted by the Department.

**vii. PWRD Silchar & Udharbond Territorial Road Division: -**

The Executive Engineer, PWRD Silchar & Udharbond Territorial Road Division, apprised the District Development Commissioner Cachar, Silchar about the various projects undertaken by the Department. The Executive Engineer, PWRD informed that out of 22 ongoing schemes, 2 will be completed by March'23, 3 schemes by April'23 and 17 nos. of schemes will be completed by December' 2023. The DDC requested to expedite after reviewing the progress report submitted by the Department. On being enquired about the Construction of RCC Bridge over Madhura River, the Executive Engineer informed the construction of the Bridge along with approach roads will be completed by 31<sup>th</sup> May. The EE, PWD(R) also informed that Construction of approaches of bridge at Badrighat (Barenga Pt. I & Kashipur Pt. I) over Barak River will be completed by 31<sup>st</sup> May' 2023.

**viii. PWRD Borkhola – Katigorah Territorial Roads Division**

The Executive Engineer, PWRD Borkhola – Katigorah Territorial Road Division, apprised the District Development Commissioner Cachar, Silchar about the various projects undertaken by the Department. The Executive Engineer, PWRD Borkhola – Katigorah Territorial Road Division informed that out of 25 ongoing schemes, 4 nos. of schemes will be completed in May, 7 nos. of schemes will be completed in September and 14 nos. of schemes before the month of December' 2023. The DDC requested to expedite after reviewing the progress report submitted by the Department.

**ix. PWRD Lakhipur Civil Sub-division Territorial Roads Division**

The Executive Engineer, PWRD Lakhipur Civil Sub-division Territorial Road Division, briefed the District Development Commissioner Cachar, Silchar about the various projects undertaken by the Department. The Executive Engineer, PWRD Lakhipur Civil Sub-division Territorial Road Division informed that out of 4 ongoing schemes, 3 (three) nos. of schemes will be completed in May and 1 in September' 2023. The DDC requested to expedite after reviewing the progress report submitted by the Department.

**x. PWRD Sonai - Dholai Territorial Roads Division**

The Executive Engineer, PWRD Sonai - Dholai Territorial Road Division, apprised the District Development Commissioner Cachar, Silchar about the various projects undertaken by the Department. The Executive Engineer, PWRD Sonai - Dholai Territorial Road Division informed that out of 43 ongoing schemes, 7 schemes will be completed by May'2023, 5 schemes in December' 2023 and 31 other schemes before the end of next Financial year. The DDC requested to expedite after reviewing the progress report submitted by the Department. On being enquired about the Construction of RCC Bridge No-1/1 over river Sonai –Dungripur road including approaches and protection works, the Executive Engineer informed that the project will be completed before 31<sup>th</sup> May positively.

**xi. PWD (B) Silchar, Sonai & Dholai Territorial Building Division & PWD(B) Udharbond, Lakhipur, Borkhola & Katigorah**

The Executive Engineer, PWRD Silchar, Sonai & Dholai Territorial Building Division & Executive Engineer, PWD Udharbond, Lakhipur, Borkhola & Katigorah apprised the District Development Commissioner Cachar, Silchar about the various projects undertaken by the Department. The Executive Engineer, PWD(B) Sonai - Dholai

Territorial Building Division, informed that out of 16 ongoing schemes, 2 will be completed in May'23, 6 schemes in the month of December' 2023. The DDC requested to expedite after reviewing the progress report submitted by the Department. The EE also informed that the work of construction of Nehru College, Pailapool will be completed by June'23.

Again the Executive Engineer, PWD Udharbond, Lakhipur, Borkhola & Katigorah apprised the DDC that out of 22 ongoing schemes, 8 schemes will be completed before June'23 & 15 nos. schemes will be completed in the next Financial Year. The DDC requested to expedite after reviewing the progress report submitted by the Department.
