DDC MEETING TRAILED BY PUBLIC INTERACTION AND FIELD VISIT WITH MEMORABLE NIGHT HALT AT UDHARBOND BLOCK OFFICE UNDER UDHARBOND OF CACHAR DISTRICT.

20th Dec' 2021: The District Development Committee (DDC) Meeting, which is by custom held every month in the District with all Head of Offices, took place at Udharbond Block Office on 20th Dec' 2021. A team from the District Administration, Cachar headed by Smti. Keerthi Jalli, IAS, Deputy Commissioner, Cachar accompanied by the other Head of Offices of the district reached the destination at 2:00 P.M. The inhabitants of the said locality including SHGs open-heartedly welcomed all with their home-made belongings. The prolonged discussions in the DDC Meeting lasted upto 5:30 P.M. in the evening with review of works under various Departments of Cachar District, especially the areas under Udharbond LAC. Later, the team went to various places in close proximity such as Kadamtala, Pangram, Khashpur and Tikalpar for Field Visit. Close at hand, the Deputy Commissioner, Cachar had an interaction session with the inhabitants of that locality and came to know about scores of inconveniences they had been going through, which were partially sorted out on spot by the Deputy Commissioner, Cachar. The people of the locality subsequently submitted the Memorandums to the Deputy Commissioner, Cachar.

The team headed by the Deputy Commissioner, Cachar held the night with all other accompanying Officers in the said locality and made the night memorable in authentic sense. The team had the privilege to enjoy the dinner with all the inhabitants of that vicinity.

PUBLIC INTERACTION & FIELD VISIT on 21st DECEMBER 2021

After a night long interaction and get together program with the people of the areas, the following day on 21st December, 2021, at 7 O'Clock in the morning, the team went to Field Visit wherein the Deputy Commissioner, Cachar inspected Low HT Line Connection at Salganga for improvement including the site of Retrofitting Works under Jal Shakti Abhiyan. Two Number of Bakery Units and Shops along with Tikalpar School were also visited by the team headed by the Deputy Commissioner, Cachar. The Deputy Commissioner, Cachar was disappointed on attendance of fewer teachers at Tikalpar No. 57 LP School. The Team also visited the works of Water Supply Schemes under 14th Finance Commission where land owners were felicitated by the Deputy Commissioner, Cachar. Lastly, the Team visited AWC No. 81 and checked the Growth Chart and Registers followed by the participation in National Anthem. During the visit of the Deputy Commissioner, Cachar, a few problems were noticed and instructions were given

to the concerned officers to resolve the issues. Further, the Circle Officer (A), Udharbond was given instruction to make liaison as Nodal officer with the concerned officers for following up the decisions taken during the Field visit which are recorded as follows:

1. For low lying of HT Line, the DC, Cachar instructed the AGM, APDCL to look into the matter and sort it out immediately.

Action: AGM, APDCL, Cachar

2. Instructions were given to the EE, PWRD Silchar & Udharbond to widen the road side drain which were found to be narrow. Further, the DC, Cachar requested the EE, PHE Silchar Division II to renovate/repair the pipeline under JJM.

Action: EEs, PWRD Silchar & Udharbond and EE, PHE Silchar Division II.

- 3. AWC No. 81: The DC, Cachar checked the growth chart of children and found it satisfactory. But finding the Centre as deplorable, the DC, Cachar gave instruction for earthfilling works along with rooftop works to be taken up immediately.
- The Deputy Commissioner, Cachar expressed displeasure over the absence of Head Teacher and Asst.
 Head Teacher of Tikalpar 57 number LP School during the visit of the DC, Cachar on 21st December
 2021.
- 5. Bakery Unit: 2 nos. of Bakery Unit were visited and found to be satisfactory.
- 6. 14th Finance Commission works were also inspected and found satisfactory.
- 7. The Executive Engineer, PHE Silchar Division II was requested to look into the issue of drinking water supply under JJM.

Action: EE, , PHE Silchar Division II

The Deputy Commissioner, Cachar expressed her satisfaction on the successful Programme and appreciated Smti. Aditi Nunisa, ALRS, Circle officer (A) & Nodal officer, Udharbond, Smti. Sushmita Dam, Block Development Officer, Udharbond Development Block and Shri Bappa Paul, A.E., for putting in their sincere efforts, which is note-worthy.

The meeting at Udharbond Block Office Auditorium was presided by Keerthi Jalli, IAS, Deputy Commissioner, Cachar. At the outset, she welcomed all the members present in the meeting and then started Department wise discussions which were recorded as follows:

1. PWD NATIONAL HIGHWAY: The Executive Engineer apprised the Deputy Commissioner about the various works undertaken by the Department and their present status. The DC enquired about whether Road safety device & road furniture provided by the Department had proven to be beneficial in reducing road accidents. The DC thereafter instructed the EE to conduct a survey regarding the utility of the devices in reducing road accidents and submit a report. Regarding Silchar bypass from ISBT to Sonabarighat work, the EE told the DC, Cachar that the work would be completed by 31 January 2022. Regarding poor plantation along the Highways, the DC instructed the EE to sent a proposal to the DC, Cachar in this connection.

Action: EE, PWD National Highway

2. PWD BUILDING: The DC, Cachar instructed the EE, PWD Building to expedite and finish the works of Model Degree College, Borkhola positively by March 2022. Regarding Repairing / Renovation of Teacher's Training College, Silchar, the EE apprised the DC that work is going on priority basis and would be completed soon. Asking to explain the slow progress of construction of New School Bldg. for Secondary Section in existing upper primary school at Jorkhal Tribal M.E. School in Cachar District under RMSA, Assam (Package No. 3) (2016-17), the DC, Cachar instructed the EE, PWD Building to give a showcause notice to the Contractor. On enquiry by the DC, Cachar about the pending works of Establishment of Cultural Research Centre at Assam University, Silchar, the EE informed the House that there were some land issues involved

to which the DC requested to expedite and start work in some other land if the present land was not feasible. Regarding the works of Dental College, the DC, Cachar requested the EE to provide estimates of the boundary wall of the whole Dental College. On being asked about the slow progress of work (37%) the EE apprised the DC that the Contractor was not showing interest in starting the work. The DC instructed the EE to give showcause to the Contractor and also suggested to go for re-tender if necessary. On construction of 4 nos. of Model High Schools in 4 different locations in Tea Garden areas, the DC, Cachar gave instruction for the Inspector of Schools & the DEEO to get involved as part of the Monitoring Committee and a showcause notice to be issued to the District Sports Officer to stop work on Youth Hostel. Further, the IS was also instructed to take over Monierkhal Tea Estate Model High School which had been completed. On GAD Mini Secretariat works, the EE informed the House that the work for boundary wall would be completed by January 2022. The DC, Cachar expressed displeasure about the low quality of wood being used in the remodeling of Circuit House and requested the EE, PWD Building to look into the matter. Replying to the query of the DC, Cachar over the slow progress of work of construction of 2 (two) storied New Building in Cachar Treasury Premise, the EE said that the department had not received money from the Director of Treasuries. About the slow progress of work of Construction of Indoor Sports Stadium at Lakhipur, the EE informed the House that a notice have been given already to the Contractor to expedite work. The EE further informed the DC, Cachar that construction of New Auditorium cum District Library, would be started soon as soon as a minor issue of drawing is sorted out. Regarding Construction of New School Building at N.G. Sonai H.S. School, Sonai under MSDP 12th Plan, the EE, PWD Building informed the House that only toilet work was left and handover would be done by March 2022. Regarding release of funds for 4 nos. of Sadbhav Mandaps, the DC, Cachar requested the EE, PWD Building to sent a reminder to the Director, Char Areas Development Department. On the issue of 40 beded ICU at SMCH under CSR, the DC, Cachar instructed reminder to be issued for floating of tender by the Chief Engineer Office. Regarding building under occupation of CRPF for construction of Sadbhav Mandop at Sonai Block (HQ) under MSDP 12th Plan, the DC, Cachar gave her assurance of sorting out the issue and gave instruction to the EE, PWD Building to write a letter to her in this connection. The DC, Cachar requested the EE, PWD Building after reviewing the following progress reports of PWD Building submitted by the Executive Engineer.

3. PWRD LAKHIPUR: The Executive Engineer, Lakhipur apprised the House on the progress made by his department stating that for PMGSY Phase I (2008-09) 2 nos. had been completed and 2 nos. were ongoing and the bridge work would be completed by February 2022. Regarding 2014-15 CM Special Packages, against 2 sanctioned schemes, 1 had been completed and 1 was ongoing which would be completed by January 2022. Regarding the sanctioned work under 5th Assam Finance Commission, the EE informed the DC, Cachar that it would be completed by January/February 2022. The Deputy Commissioner instructed the Executive Engineer, PWRD Lakhipur to expedite all the pending works.

Action: EE, PWRD Lakhipur

4. PWRD SILCHAR & UDHARBOND: The Executive Engineer apprised the Deputy Commissioner, Cachar about the Vivekanda Bhawan outlet work stating that estimates had been sent and work shall be started soon as soon as it arrive. Regarding PMGSY works, the EE stated that they would be completed by February 2022. RIDF-NABARD works would be completed by May 2022, SOPD-G (2019-20) works by March 2022 and SOPD-ODS works by February 2022. Regarding Conversion of 1000 Nos of SPT Br. To

RCC Br.(2017-18), the EE informed the House that they would be completed by February 2022. In respect of survey of Silchar-Retzawl, the EE appraised the DC that a big amount would be needed for the survey. Regarding the alternate road proposal for Airport, the EE informed that estimates have been submitted and work would be started soon and there would also be a meeting in this regard at New Delhi. The DC, Cachar requested to expedite.

Action: EE, PWRD Silchar & Udharbond

5. KHASPUR: The District Development Commissioner, Cachar informed the House that after visiting Khaspur, the ancient capital of the Kachari kingdom, the Hon'ble Chief Minister had given instruction that the place should be developed to promote tourism. Hence, all departments were requested to take up some projects like road development projects to boost the tourism prospects of the place.

Action: All Departmental Heads

6. PWRD DHOLAI & SONAI: The District Development Commissioner, Cachar informed the Executive Engineer, PWRD Dholai & Sonai that NABARD was not satisfied with the ongoing works under RIDF and instructed the Executive Engineer to work more if further funds is required. Regarding APART Market Linkages, the EE apprised the DC, Cachar that the work was almost done and would be completed soon.

Action : EE, PWRD Dholai & Sonai

7. PWRD BORKHOLA & KATIGORAH: The Executive Engineer, Borkhola & Katigorah informed the House that ongoing schemes under PMGSY would be completed by March 2022 while work of conversion of 1000 Nos of SPT Br. To RCC Br. would be completed by January 2022. The DC, Cachar was apprised about a land issue regarding construction of Thalmarpar Road to South Manikpur.(Pkg. No.SE/SIL/SOPD/G/14). The DC, Cachar assured that a public meeting would be held in this regard soon. Regarding ongoing BADP schemes, the DC, Cachar requested the EE to expedite.

Action: EE, PWRD Borkhola & Katigorah

8. SILCHAR WATER RESOURCES: The DC, Cachar was informed that all ongoing schemes under CM's Package and NABARD would be completed by January 2022. Under SOPD-FDR, regarding slow progress of work of Reconstruction of flood embankment along L/B of Barak from Uttarkrishnapur to Tarapur at Bethukandi area of Silchar Town including protection works, the EE apprised the House that there was a delay because of a problem which would be sorted soon and the target for completion had been set for March 2022 while the dyke work of Shibbari area would be completed by March 2022 as informed by the contractor. The DC, Cachar requested to expedite.

9. AGRICULTURE: The District Agriculture Officer, Cachar informed the DC, Cachar that deletion of ineligible names under PM-KISAN was done and 1473 were found to be eligible. 5 nos. of Shallow Tubewells schemes were pending and demonstration was going on for APART while the Sprinklers target of 900 had been achieved.

Package No.- AS- 03 71." Could not be completed yet because of the Contractor for which a notice has been sent. The DC, Cachar instructed to expedite and complete it by March 2022. Improvement & Upgradation of Srikona Mohanpur Road would be completed by February 2022 while work had been started for Borjalenga Road. The Deputy Commissioner, Cachar requested the Executive Engineer to expedite all ongoing schemes.

13. URBAN WATER SUPPLY: The Deputy Commissioner, Cachar expressed displeasure over the poor progress of AMRUT Mission and necessitated a meeting of Urban Water Supply Department with the DC, Cachar on 12th January, 2022.

14. **SERICULTURE**: The Deputy Commissioner, Cachar gave strict instruction to the Additional Director of Sericulture, Cachar to utilize the available manpower and work seriously to get results and action would be initiated if progress is slow.

15. FISHERY: The Deputy Commissioner, Cachar requested the District Fishery Development Officer, Cachar to ensure Cachar remains at the top position in respect of fish production in Assam. Regarding the Fish Training Centre, the DC, Cachar requested the DFDO to prepare estimates in collaboration with Irrigation, Dholai & Sonai. On being asked whether any help was required, the DFDO requested the DC, Cachar for an additional fund of Rs. 5 lakhs.

- Due to shortage of materials mainly Psc poles in Silchar area, contractors are purchasing poles even from Alipurduar, West Bengal, Nagaon & Upper Assam which are delaying the progress.
- Till today around 2000 nos. of connections has been released to individual households under Cachar Electrical Circle.
