

**MINUTES OF THE DDC MEETING HELD ON 29TH MARCH, 2022 AT 12.00/M IN
THE CONFERENCE HALL OF THE DEPUTY COMMISSIONER, CACHAR, SILCHAR.**

The meeting was presided by Rajib Roy, ACS, District Development Commissioner, Cachar. At the outset, he welcomed all the members present in the meeting. Then Department wise discussions was started which were recorded as follows :

1. **AAGY** : The District Development Commissioner informed the House that a CM's Team would be visiting Cachar on 9th, 10th and 11th April to inspect the schemes in 14 AAGY villages of Cachar and requested all the concerned departments like PHE, Education, PWD Roads, Health, Agriculture, AH & Vety, Fishery and Social Welfare to be on stand by for providing any assistance that may be needed by the visiting team. The DDC also requested all the concerned Departments to mail the name of schemes along with photographs to the DDC, Cachar.

2. **GANDHI PANORAMA** : The DDC apprised the members present about Gandhi Panorama, a festival of films on Gandhiji and his principles to be organized at Bongo Bhawan Auditorium on 03/04/2022 which is being personally monitored by His Excellency, the Governor of Assam and instructed all the Heads of Departments to attend with their office staff and families to make the festival a grand success.

3. **PWD (BUILDING), SILCHAR** : The EE, PWD Building apprised the District Development Commissioner, Cachar that the work of DC's Main Office Building would be completed within 15 days and the work at Circuit House would be completed within a week. The DDC, Cachar requested the EE, PWD Building to expedite. The DDC, Cachar requested the EE, PWD Building to expedite the work of pending MsDP Schemes and submit UCs at the earliest.

4. **PWD LAKHIPUR TERRITORIAL ROADS DIVISION** : The DDC, Cachar informed the EE, PWRD Lakhipur that the progress of work was slow and there were many schemes pending to be completed and instructed the EE to take note and expedite.

5. **PWD DHOLAI SONAI TERRITORIAL ROADS DIVISION** : The DDC, Cachar informed the EE, PWRD Dholai & Sonai that the repairing of Sonai Road was not done yet and instructed the EE to look into the matter.

6. **PWD SILCHAR UDHARBOND TERRITORIAL ROADS DIVISION** : The Executive Engineer informed the DDC, Cachar that all projects would be completed by May 2022 while 1 project under RIDF would be completed by October 2022. The DDC, Cachar requested to expedite.

7. **PWD NH DIVISION** : The DDC, Cachar instructed the EE, PWD Silchar NH Division to complete the Balance work of Silchar bypass under SOPD 2020-21 by 31st May 2022 without fail.

12. APDCL : The AGM, APDCL informed the District Development Commissioner, Cachar that there was an outstanding due of Rs. 6 lakhs payment to be made to APDCL by Srikona Girls High School. The DDC instructed the AGM to disconnect the line if payment was not made soon.

13. ELECTRIFICATION TO ANGANWADI CENTRES AND SCHOOLS : The DGM, APDCL informed the DDC, Cachar that connections had been provided to 859 out of 1002 school buildings. Regarding pending electrification to AWCs, the DDC, Cachar requested the District Social Welfare Officer to take up the issue with APDCL. The DDC, Cachar instructed the DGM, APDCL to submit the list of schools and AWCs for which connection had been provided to the Education and Social Welfare Department and requested the three departments to work in tandem.

14. DCs CONFERENCE ACTION POINTS : The DDC reminded the House again that the reports of DCs Conference Action Points and Monitorable Targets had to be sent by the Departments every month and all defaulting Departments who were yet to send in pursuance of the letter sent to them on 21st March, 2022 were to send it at the earliest.

15. SDGs : The DDC, Cachar instructed the defaulting Departments to send the data of SDGs at the earliest.

At the concluding part, the District Development Commissioner, Cachar informed the House that from the next DDC Meeting a new format of recording DDC Minutes would be used for which all the Departments would need to intimate the DDC about the number of CS, CSS, EAPs etc schemes physically monitored and the number of UCs along with amount submitted by the Departments apart from their regular progress reports in the DDC Meeting.

The meeting ended with vote of thanks from the Chair.
